Old Business & Manager's Report

Dawn Bringe went through her action item list:

• Will request a copy of the police report from the sheriff's office regarding the trespass and vandalism in May at the pool for the Association records.

- <u>Pool Gates</u>: the steel replacement panels for the pool gates will be delivered this week and a time scheduled possibly next week for installation.
- <u>Pool Pavers</u>: Dawn Bringe and the Board discussed the quote received by the pool maintenance company and the need to complete the grouting around the pool that the Board believes still needs to be done to complete the project, along with the replacing of a few broken pavers.
- <u>Pool Restrooms</u>: New Partitions ordered with no delivery date due to Covid-19, metal lock guards to be delivered this week.
- <u>Ground Depression behind playground area</u>: Pinellas County to replace piping in that area. Dawn will follow up to get the County's anticipated date for the work to begin.
- Entry Signs Lighting: County Permitting Department issue continues and Dawn will follow up.
- South Retention Lake fenced in area: As requested by the Board, the chain link fence will be straightened and Dawn will have a sign made that clearly states access to fishing in that area is prohibited.

New Business

Well irrigation system emergency: Dawn Bringe reported she received a call that there was possibly what appeared to be lightning damage to the well irrigation panel because the wires to the pump were fried. The entire panel must be replaced because the parts that the current panel uses are no longer available. Dawn notified Shawn Rigney of the emergency repair so that the common grounds grass and plants would be irrigated and did not die. A temporary bypass to the system was done until the new panel could be ordered and installed. The new panel is expected to be delivered early next week.
